

RE: JACKSONVILLE MEMORIAL HOSPITAL AMBULANCE AND EMERGENCY DEPARTMENT KILLING OF MAZARINE LEVY-SNYDER, MEDICAL EXAMINER CASE NUMBER 190400632, STATE FILE NUMBER 2019043242, and REQ NUMBER 2020371911, HOMICIDE INVESTIGATION NEEDED ON BEHALF OF PUBLIC SAFETY, QUESTIONS AND PICTURES REGARDING JACKSONVILLE FLORIDA MEMORIAL HOSPITAL MOUTH DEVICE POSSIBLE SUFFOCATION TO DEATH SABOTAGING AND STOPPING HEART AND LUNGS, A PROBLEM SHE HAS NEVER HAD, PURPOSE OF MOUTH PIECE WHILE ONE IS ALLEGEDLY DEAD NEEDS REASONING, LABELING LIVE PEOPLE DEAD, REPLICATED DECEPTIVE MEASURES USED TO LEAVE PATIENT ALONE, NO SAFETY MEASURES IN PLACE TO VERIFY AND CONFIRM DEATH, KILLING PATIENTS VIA REPLICATED MEDICAL ERROR ADMINISTRATIONS SUCH AS LABELING LIVE PEOPLE DEAD AND MORGUE KILLINGS OF LIVE PEOPLE BY HYPOTHERMIA – FREEZING LIVE PEOPLE UNTIL THE BODY STARTS SHUTTING DOWN, USING MEDICAL DEVICES TO TORTURE THE HOSPITAL CREATED UNDEAD LIVE PATIENT, HOMICIDE BY MEDICAL ERROR HOSPITAL ADMINISTRATION, SEE ATTACHED PICTURES,

Dear Human Rights/ Right to Life Advocates, Attorney General Ashley Moody, Dr. Peter Gillespie, Maliza McMillan, Sheriff Mike Williams:

My name is Miriam Snyder. I am Mazarine Levy Snyder's daughter. I write this affidavit regarding the attached pictures of my mother while in the Jacksonville Memorial Hospital Emergency room outpatient department.

Foremost, Dr. Gillespie, thank you for replying to my email regarding the many errors on my mother's death certificate, posted at:

Thank you for doing the autopsy in the midst of Jacksonville Emergency Room Memorial Hospital agents telling us that the autopsy was initially declined when it was not and your office had not heard of my mother. I am unclear why Memorial Hospital Emergency/Outpatient agents LIED.

I anxiously wait for the autopsy results because my mother was not in deadly health when I brought her to Jacksonville Memorial Hospital. She was unresponsive and, in my opinion, she was induced in the hospital by radiation torture, more specific unregulated ionizing radiation external beam torture, designed for induce hospitalizations. See exhibit 4.

Radiation weapons need to be investigated and regulated. Currently such weaponry is in the hands of satanic cult members and these weapons are being used to torture and induce hospitalize innocent and healthy people for medical error hospital killings. Despite my efforts to expose these eugenic crimes and keep her safe, my mother was killed due to these unregulated eugenic, satanists led, conspiracy to murder crimes. She was induced in the

Jacksonville Memorial Hospital medical error killing program via the unregulated ionizing radiation beam torture program.

There needs to be serious regulation on radiation technology/weaponry, more specific radiation beam weapons, and an end to premeditated hospital medical error killings that complement the plotted induced hospitalizations. Please see the same eugenicist and satanic cult leader, Boyden Gray, who is name aligned to unregulated ionizing radiation in exhibit 4 and name aligned to medical error hospital administration killing and training in exhibit 5.

This killer and his cult members, who all hold law, judicial and education titles, are also name aligned to deadly pathogen administration programming under the disguise of human research studies and funding. They fund and work out of laboratories that CREATE deadly replicating injectable viruses such as cancer, lupus, herpes, HIV, diabetes, etc. Please see the reference section. The NYS University of Rochester Medical Centers is the headquarters and the entity that created the deadly viruses that harmonized Africa, and since unregulated, recently harmonized Atlanta, causing another one of their plotted epidemics.

The Atlanta deadly plotted viral epidemics have manifested for more sinister reasons. They are programmed for induced hospitalizations of primarily young people under the disguise of the viral epidemic infestation. The induced hospitalization makes way for the medical error plotted killings and the creation of the undead, like what was done to my mother.

The difference is that with young people being induced hospitalized under the disguise of any deadly viral infestation, the eugenicists, more specific, the medical error hospital administrators, label them dead when they are alive, for live organ harvesting and sales. The eugenicists have trained the eugenic hospital administrators with their prepared list of plotted and a variety of hospital medical errors, that effectuate the undead and finally killing the young people for their organs. Above all, I write this letter regarding some of the many pictures I took when my mother was in the care of the Jacksonville Memorial Hospital Emergency Department. I had to fight to get to see her in there and I do not believe this should have happened.

The ambulance agents would not let me ride with her and the hospital would not let me be with her. Every effort was made to have her alone and I do not understand such, particularly because I was told she was dead within 45 minutes after she was brought there alive. The family needs to know what happened.

In the attached pictures, I was told she was dead. In one of the attached pictures her eyes are open with a device placed in her mouth. I have the below questions regarding the device in her mouth and the below pictures of my mother who was labeled allegedly dead while in the Jacksonville Memorial Hospital Emergency Department. I pray the Medical Examiner can investigate and address and answer these questions directly or via the long waited anticipated autopsy report and I hope the autopsy is not erroneous, like the death certificate., that I have to not fight to correct.

In the below attached exhibit 1 picture, medical experts have informed me that my mother was alive. Her eyes were open. The Memorial Hospital Emergency Room nurse and doctor told me my mother was dead, yet her eyes were open in this picture and closed in the other exhibit 2 picture.

My mother, Mazarine Levy Snyder did not have any respiratory, lung or heart problem ever. Yet the mouth device in the 2 picture exhibits below were put on her while allegedly dead. The following questions need to be addressed.

- 1. What is the device on my mother's mouth? What is its purpose? Does it mute the mouth? Does it have the capabilities to suffocate a person?**
- 2. Why was the below pictured mouth device put on her while she was allegedly dead with her eyes open? What is the purpose of putting any device on a person that is allegedly dead?**
- 3. Was she alive and this mouth device used to suffocate her, create a lung and heart problem she has never had in her life?**
- 4. Was this an intentional hospital extubation, administered under the disguise of a medical error?**
- 5. Was the mouth device in the exhibit 2 picture used to create an Airway Safety medical error suffocation, lung and heart problem that never existed before?**
- 6. Was the pictured mouth device used to deaden her heart and lungs, since as evidenced by her open eyes and the tear in her eye, she was alive?**
- 7. Was my mother ambulance and hospital killed under the disguise of medical errors, embedded in being injected into a coma, and thereafter her airways obstructed consistent with the airway safety and unplanned exubation medical errors listed on pages 249 and 271 on the below link**

- 8. Why was my mother labeled dead, when she was not?**
- 9. Why was her mouth muted with the pictured device?**
- 10. Why was she killed in the Jacksonville Memorial Hospital Emergency Room?**

In closing, Dr. Gillespie, I seek closure. My innocent mother was killed in the Jacksonville Memorial Hospital Emergency Department. This could have been avoided. I look forward to an accurate autopsy report, or the body will be exhumed until the truth is transparent. I

pray the autopsy report will be accurate and not erroneous like the death certificate was, when such could have been prevented. Your professional response to this letter is greatly needed immediately. My mother's family members and I anxiously await responses to the above questions and for an accurate autopsy report to bring closure and clarification.

Sheriff Mike William and Attorney General, Moody, I would like a criminal report and number for Jacksonville Memorial Hospital ambulance and emergency room agents homicide, murder, and conspiracy to kill under the disguise of intentional/deliberate medical error hospital administration, master deceptions in labeling and identifying her as dead, when she was not, and torturing her with the pictured device while she was alive and labeled dead.

Furthermore, the hospital should be charged with the criminal creation of the undead, labeling people dead when they are not, and thereafter hospital killing the person under additional medical errors like HYPOTHERMIA, freezing to death live people in the morgue UNTIL THE BODY STARTS SHUTTING DOWN. There are no safety nets in the hospital to stop this.

These criminal charges are greatly needed on behalf of my mother, but additionally on behalf of young people, particularly the young people victimized in the current Atlanta epidemics. Those young people will be induced in the hospital under the disguise of the epidemic infestation inflicted on them and will be killed under replicated medical error administrations including but not limited to: the creation of the undead, labeling live people dead, so family members will leave their love ones in the hospital alone to be hospital killed, denying family members the right to see their loved ones whether live, undead, or dead, organ harvest, and finally plotted hospital medical error killing under hypothermia, freezing to death live people in the morgue until the body starts shutting down.

I believe my mother was tortured and killed based on the above summarized Florida Memorial Hospital unregulated and no safety measures in place to counteract the above medical error administrations. On behalf of my mother's Godly life and on behalf of humanity, I seek investigations with validating evidence and prosecution of all ambulance and emergency room conspiracy to kill medical error administrators/conspirators.

The current Atlanta criminal epidemic and infestation of young people was done for no other reason but to induce hospitalize young people under the disguise of the deadly infectious injections rendered to the young people, and the above summarized medical error killing program is in fruition as exemplified on the torture, deception, and labeling as dead of my mother, while she was alive, to have her left alone in the hospital to be medical error tortured and killed.

This criminal inducement of young people into the hospital is for no other reason but to label live young people dead, to get live organs and sell them. This is a bonafide Regional Killer Boyden Gray mentored hospital medical error training under the disguise of the hospital agents making money. In reality, these gross killings are needed for his satanic requirements and earthly power.

The above noted criminal reports and police report numbers are needed, on behalf of public safety and public policy. Please send such to me. Please note my NY address. This is my permanent address. Again, to all human rights advocates, thank you.

Finally, please note the exhibits attached show that all of the eugenic crimes, infestations, epidemics, medical error hospital killings, criminal insane creation of the undead, and mentorship of these eugenic killing programs, all point back to the mentorship of Regional Killer Boyden Gray and the headquartered eugenicists and infectious disease laboratories and specialists working out of the NYS University of Rochester Medical Center. AFFIDAVIT

I attest under the laws of God and the United States that the above statements and the exhibits are accurate and truthful. I have personal knowledge and witnessed the induced torture hospitalization and the Jacksonville Memorial Hospital ambulance and emergency room medical error hospital administration killing of my mother, MAZARINE LEVY SNYDER. My mother was alive when they said she was dead as exemplified in the pictures. This hospital's medical error killing rate, and the overall in hospital death rates, need to be supervised, investigated and publicized. Safety measures to be put in place to confirm the death of patients so this hospital will not continue labeling live people dead to make family members leave the loved one alone in the hospital.

I found out my mother was killed in the hospital via the erroneous death certificate that states place of death, Jacksonville Memorial Hospital emergency room. I did not know she was alive when she was brought to the hospital. I was told she was dead from the home and the ambulance. I would never had left my mother had I known she was alive. I was not allowed to stay with her and had to fight to see her. They wanted her alone to kill her and they did.

The device put on my mother's mouth while she was allegedly dead with tears and her eyes open was used to facilitate the hospital plotted medical error, killing of her. There is no lawful or reasonable reason whatsoever for an allegedly dead person to have a muted mouth device put on her. Emergency room doctors and nurses told us that my mother was dead and made us leave. I had to fight to get to see her. This was ridiculous. It was a plotted hospital homicide.



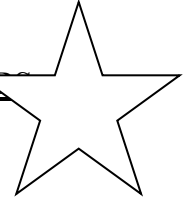

The Institute of Medicine's 2000 report, **To Err Is Human,** and the widespread media attention it received, dramatically increased awareness of the extent of **medical mistakes in U.S.**

hospitals ■ Since then, a number of states and national quality organizations have adopted policies requiring or encouraging medical professionals to tell patients and families when unanticipated "adverse events" occur. Some organizations and insurers have gone even further by adopting programs through which disclosures of adverse events are accompanied by offers of compensation

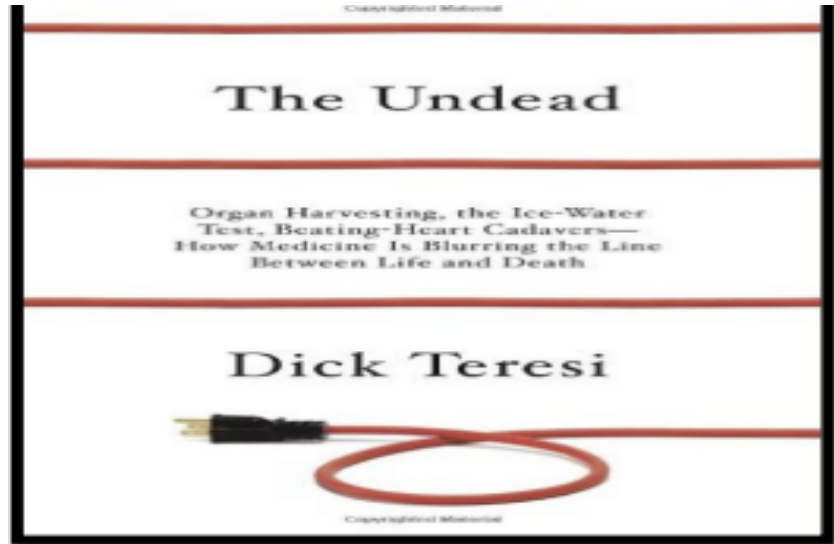
(known as disclosure and offer or D&O programs). Still, prompt disclosure of **medical**

errors and fair compensation remain the exception rather than the rule. Thomas H. Gallagher, M.D., associate professor of medicine at the University of Washington,

and Michelle M. Mello, J.D., Ph.D., M.Phil., **C. Boyden Gray** Associate Professor of Health Policy and Law at the Harvard School of Public Health, seek to more fully understand the effects of disclosure initiatives and innovative D&O programs on **malpractice costs and patients' access to compensation**. Their project, **Responding Justly to Patients Harmed by Medical Care: Disclosure, Compensation, and Litigation**, explores how policy levers can be used to make disclosing errors more routine and evaluates the design and effectiveness of D&O programs. Their work should help policymakers better understand the potential of these initiatives and how they might best be **integrated** into broader **medical liability reforms**.

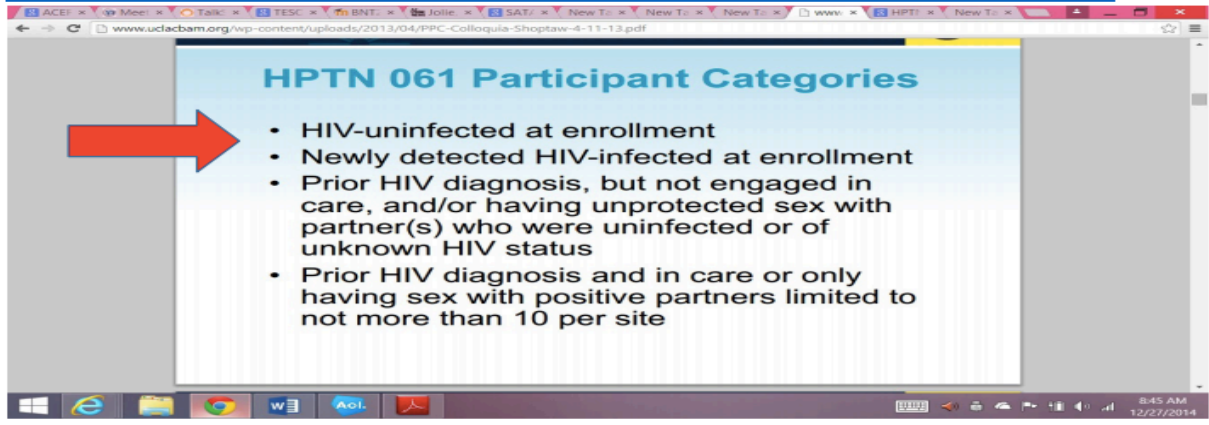

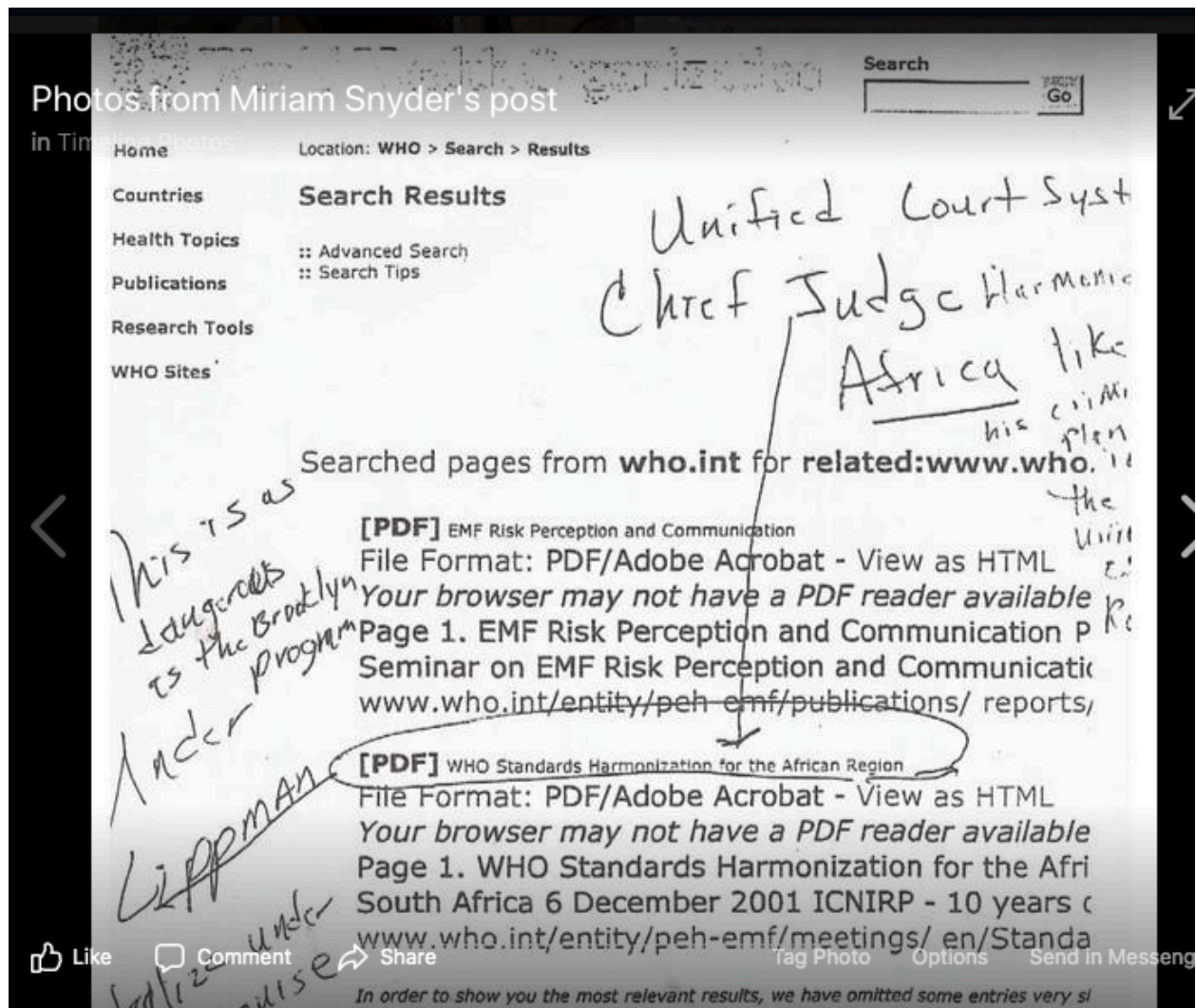


