



Eulogy

Son of the Soil (Rev Selwyn L Vanterpool)

Selwyn Lorenzo Vanterpool, my father, was a man that put family, community, and God at the centre of his life. Despite the ministry taking him to many different places throughout his career, the community of the British Virgin Islands remained central to his identity. As many quoted to us in recent days, he often said in the context of The Valley Methodist Church in Virgin Gorda, BVI which was just a short walk up the road from his childhood home - "This is where I was hatched, this is where I was matched, and God willing, from here I will be dispatched" His belief in God, support for the church and in particular the Methodist church in the Caribbean and Americas (MCCA) and more specifically the entire Leeward Islands District will always be remembered. Those familiar with his ministry may remember one of his philosophies, "Expect Great Things from God! Attempt Great Things for God". He certainly lived his life aware of the call of God, and with the quiet inner confidence that God had equipped him to meet any challenges that were thrown his way and an unwavering desire to be faithful to God to the end.

His Ministry

Known to many as Reverend Vanterpool or more simply Rev throughout the years, whether they knew him in his early career as a young minister in Monserrat, Antigua, or Aruba, where he might have been the one that was there for happy family moments of weddings or christenings or simply the one in the pulpit on Sunday morning services. During a recent tribute from a congregation in Antigua he was described as the People's Pastor and his concern and love for his members could not be denied both in spiritual ways with training seminars but also in practical ways by providing rides, being familiar with what was happening in the lives of his parishioners including where they lived and visiting them at home.

Others might have known him mid-career in Dominica when the work of rebuilding the island after Hurricane David was dominant. As a child, I remember him organising the countless work teams from overseas that contributed to the rebuilding of the Methodist Schools, the Wesley High School and the St. Andrew's High School that had been destroyed in the storm along with the Layou Church that was rebuilt having been destroyed by fire. His ministry then continued in St. Maarten/St. Martin, where in addition to being Superintendent he was also Chairman of the Methodist Agogic Centre (MAC) Primary School that I also graduated from.

Finally, in his later ministerial career it was fitting that he spent those years in the Virgin Islands. Firstly, when stationed in Road Town, Tortola he was responsible for all thirteen Methodist congregations in the BVI including the sister islands of Jost Van Dyke and Anegada. Later, he then moved to being Superintendent in St. Croix where he built the Methodist Education and Outreach Complex and also organised and hosted the first District Synod there. In his last posting before retirement, he served in the St. Thomas/St. John Circuit and during that time renovated the ChristChurch Methodist Chapel. Of course, throughout the years, he had many different roles within the church including serving as the Leeward Islands District President and General Superintendent for two terms between 2000 and 2006. However, his ministry is what most of you already know quite a lot about, so I want to share more about the man.

Overcoming adversity

One of the earliest stories I have heard both about my dad and from my from dad is that as a young child he had a severe case of Typhoid Fever. He was hospitalised In Road Town and was not expected to live. In fact, things were so serious that arrangements had even been made to return his body to Virgin Gorda for burial, but God had many other plans for his life. This incident had a profound impact on his life, and in his autobiographical comments, he said "I grew up with a deep sense of gratitude to God, and a strong awareness that God had spared my life to serve Him through service to others".

Another story I have come across more recently in the Biography that Rosemary Delaney-Smith prepared on my dad is around his shyness and she recounts a story at school that stretched him to the limit when he was selected to sing a love song to a girl as part of a school concert. Clearly for an introvert that is also shy I can imagine at the time how this would have seemed like his worst nightmare. However, he prepared and responded to the challenge. In Dad's own words of that night he said, "When the night of the concert arrived, only God knows how many times I died emotionally as I sang and acted out that love song. What a relief when the duet ended! I was still alive!".

However, he also highlighted the importance of others to have noted this weakness and pushed him to overcome it and he said, he was "eternally grateful to these insightful concerned and dedicated teachers. Without their wise intervention, (he) would not be the man.", he was. I included that story as I think so many of us identify with avoiding things that are uncomfortable, but yet we know that you can't move forward without taking a leap of faith and moving beyond our comfort zones. My dad demonstrated by moving beyond the shy boy terrified to sing or speak in front of others to someone that preached, prayed, and sang in front of hundreds and thousands.

Family Background

As a child, I remember many summers spent at his childhood home in the Valley, visiting family and in particular his mother. Spending time at the BVI's world famous beaches like the Baths and Spring Bay were key to the activities of the summer, along with my father attempting to show me how to make a kite or go fishing with crabs. Unfortunately, I was never particularly good at either of those.

Virgin Gorda and the family land where appropriately will be his final resting place were incredibly important to him and throughout the years, I could see the effort he made in ensuring the family properties that he and his siblings owned were well taken care of. Despite not being a particularly outgoing individual and a true introvert like myself, my dad was a "doer" who cared deeply about the family. He made himself in effect CEO of the family business and I remember his bringing everyone together for family conferences with his siblings and their children as they discussed the family property, and what decisions needed to be made around renovations, maintenance and more.

My parents got married in 1972. They met while they were both pursing studies at the United Theological College of the West Indies in Jamaica. My mother later changed to Education and became a teacher, but my mother was the ideal minister's wife and complemented my dad. While he was quiet and reserved, she was an extrovert and a people's person and hence was naturally great at hosting the stream of visitors and ministers that stayed at our home over the years. That union of course produced my brother, Kenneth Vanterpool who lives in Atlanta, my sister, Dr Karen Vanterpool (PhD in Health Behaviour), who lives in Maryland and myself, Beverly Vanterpool, who now lives in London.

Celebrating and living life

Celebrating life and its key moments were especially important to my dad. I will always remember times like planning my 10th wedding anniversary celebration at the house at McNamara and him throwing himself into the details of planning those moments, wanting it to be perfect. Similarly, the family Baltic cruise for my parents 40th wedding anniversary in 2012 was particularly memorable and now our last family trip in January 2020 in New Orleans for my mum's 70th birthday is particularly poignant.

Over the years, during their visits to the UK we always tried to fit in as many of the top sights and activities as was possible. Whether it was going to the Chelsea Flower Show, seeing the Musical the Lion King on the London West End or one of the earlier trips back in 2007, when they came for my graduation from the University of Cambridge where I had completed by MBA. Another highlight for Dad was in 2015 when we visited Wesley's Chapel and house in London which were built in 1778 & 1779 respectively by John Wesley, the founder of Methodism.

Other particularly special moments include our 2015 cruise that included Gibraltar, which was a place that over the years he had always talked about wanting to go and see the Rock of Gibraltar. Hence, that year he finally made it there. Gardening was also a particular passion. Selecting plants for the garden at McNamara was therefore a favourite pastime. I remember many a discussion about attempts to get the perfect breadfruit tree or plum tree and whether, it was now growing as expected. As lockdown started last year throughout much of the world and particularly in big cities like London where life was significantly restricted, I started a little bit of gardening in my tiny London backyard and he was always interested in knowing whether, I had managed to keep the herbs alive or if any tomatoes had appeared.





Community

Over the years, both before, during and after his time in the ministry, it was evident that the wider community outside the church was just as important to him. Before the ministry he spent seven years in the BVI civil service and served as Clerk to the Registrar's Office, Clerk to the Legislative Council, and later as a Clerk to the Attorney General. He served in many capacities throughout the community including starting the Boy's Brigade Company in Road Town as a young man and serving as the first Chairman of the Police Advisory Committee from 1992 to 1995. He also served on many national committees in the BVI and beyond including most recently the Police Service Commission up until leaving the BVI in 2017.

My dad said, "As we give back our gifts to Society, we experience true joy and fulfilment. I discovered that, the secret of J-O-Y is found in putting.

J – Jesus first; O – Others second, and Y – Yourself last"

Post Ministry - Counsellor at Her Majesty's Prison

After he retired from the ministry after over 40 years, he worked part-time as a counsellor in HM Prison. I remember back in 2013 having detailed discussions with Dad about his work at the prison at the time and his current focus was on creating a prison curriculum targeting different parts of the prisoner population and he was truly passionate about the topic of rehabilitation and how the risk on the community could be effectively evaluated. One evidence of his impact on that community was at one of the rehabilitation programmes, one of the inmates asked to speak despite not being on the programme as he wanted to share the impact the programme had on himself and peers, saying about my dad, "You never judged us, you are like a father figure to us" and the inmate highlighted that through the programme he had grown emotionally and spiritually.

Cancer & Alzheimer's

I was at university when my dad first got his diagnosis for Prostate Cancer. Luckily, it was successfully treated with radiation at the time, however about twelve years ago, it came back. This time surgery was required which added more complexities and the need to monitor his health more closely. Accordingly, regular trips to the US to do tests, became part of the routine for my parents. After the Hurricane in the Caribbean in 2017, it became clear that they were no longer able to cope on their own in the BVI and with increased need for medical support they made Atlanta, where Ken resided their home. Towards the end of 2020, it was determined that the medication was no longer helping, and he was too weak for chemotherapy. This prognosis combined with the continued decline from Alzheimer's while all the while living in a Covid world made for a complex situation as he did not always understand everything. It was strange though that even on the bad days when he no longer remembered who my mother was, he did seem to know inherently that she was always someone that he loved and trusted. The intersection of these diseases is obviously quite heart-breaking, as while one destroyed his body the other slowly eliminated the dad with whom I had debated everything from religion to economics and politics.

His Legacy

Ultimately, he will be remembered a humble man, dedicated to the service of God, his community and family. He is often described as soft-spoken, diligent, and a faithful Christian. During his life he established and led many church and community organisations throughout the islands he served, he wrote many articles and booklets, oversaw the building and re-building of many church buildings, and impacted the lives of many Methodists throughout the region. He was one of the first Virgin Islanders (British) to become a minister in the Methodist Church as part of the MCCA conference and the first BVIslander to become District President of the Leeward Islands district. Over the years he received many awards and in 1990, he received the honour of MBE, Member of the Most Excellent Order of the British Empire for services to the community in the British Virgin Islands.

He left his impact on the lives of many across our community, whether in larger scale activities or just in those more personal moments. Whether it was being there for a celebration, housewarming, wedding, or baptism or supporting others in more challenging moments of difficulty, sickness, and death. However, he went beyond the requirements of the day job, cared deeply and always gave 100% in everything he did. Rev Vanterpool, son of the soil, father of Beverly, Kenneth and Karen, husband of Brenda, brother of Calmelita, relative, friend and minister to many more completed his life's journey, but his impact will live on in the many lives he touched for many more years and generations. His desire at the end to hear from the lips of Jesus, "Well done Thou good and faithful servant" has been met.

For the Late

Rev'd Selwyn Lorenzo Vanterpool MBE., MPS., MA., LTh.,

"Swift to its close ebbs out life's little day; Earth's joys grow dim, its glories pass away; Change and decay in all around I see— O Thou who changest not, abide with me".

So penned Henry F. Lyte in his most profound and inspirational hymn, "Abide With, Me fast falls the eventide". Our lives, on this side of eternity, are silently yet, deliberately, moving to its close. On May 10, 2021, the earthly life of Rev'd Selwyn Lorenzo Vanterpool closed, and he was transitioned to another realm.

OBITUARY FOR REVEREND SELWYN LORENZO VANTERPOOL, MBE

Selwyn Lorenzo Vanterpool was born on 24th January 1942 at the Valley, Virgin Gorda, British Virgin Islands to Jacob and Emma Vanterpool.

He received primary education at the St. Mary's Primary School, Virgin Gorda and attended the Virgin Islands Secondary School, Tortola. Upon graduation, the young Mr Vanterpool joined the BVI Civil Service where he held different posts including Chief Clerk, Registrar's Office, and Clerk to the Attorney General. His early public service was marked by a commitment which was also reflected in his service to and on behalf of the Church.

Under the leadership of the young Methodist, Bro. Selwyn Vanterpool, the 4th BVI company of the Boys' Brigade was started at Road Town. From 1960, Selwyn served the church as a Local Preacher, before offering himself as a candidate for the Ministry of Word and Sacrament. In 1967 he was presented to the Leeward Islands District Synod as a Candidate for the itinerant ministry. He offered along with Yvonne Nibbs (later Flores) and Edris Christopher (later O'Neal) who offered for the Wesley Deaconesses Order. All three were accepted for training.

Rev'd Selwyn Vanterpool candidated at a time of social and political turmoil, a time of growing Caribbean awareness, movement towards decolonisation and the creation of the new Caribbean person. 1967 was the year that the MCCA became an autonomous Caribbean church within world Methodism. That year, the largest number of Methodist candidates for the ministry was accepted for training.

Upon acceptance for the ministry, Rev'd Vanterpool was appointed to serve as Pre-collegiate Minister for one year in the Antigua Circuit. In September 1968 he commenced theological training at the United Theological College of the West Indies (UTCWI), Jamaica, whence he graduated with the Diploma in Ministerial Studies. He was also awarded the Licentiate in Theology by the University of the West Indies.

Upon graduation from the UTCWI Reverend Selwyn Vanterpool was assigned to the Leeward Islands District and took up his first assignment as a circuit minister in the Montserrat Circuit where he was stationed for three years. He was ordained at the District Synod held in Nevis in 1974. In 1975 he was stationed to the Antigua Circuit until his transfer in May 1977 as Superintendent Minister to the Aruba Circuit.

From the Aruba Circuit, he proceeded on study leave. Having previously completed a course in "Chaplaincy in Prisons, Schools and Police Services," at Luton Industrial College, UK, Rev'd Vanterpool was admitted to St. Paul's University, Ottawa, Canada in 1978. There he pursued studies in Counselling. He was one of two students selected to assist the staff as Counsellor-in-Residence. He graduated from St. Paul's in 1980 with a double Master's degree- the Master of Arts Degree in Marriage Counselling (MA) and Master of Pastoral Studies (MPS).

In September 1980, Rev'd Vanterpool and family moved to their station in Dominica. There he served as circuit minister for one year. He was assigned as Superintendent Minister of the circuit during 1981-83, a time of national reconstruction following Hurricane David which struck the island one year after it attained independence from Great Britain.

Between 1983-1988 he was the Superintendent Minister of the St. Maarten/ St. Martin Circuit. While in St. Maarten he was also the Superintendent Minister of the St. Eustatius Circuit to which he travelled frequently in order to fulfil ministry and to oversee the work there. In 1988 he was stationed in his home circuit, the BVI Circuit, and served as Superintendent Minister for seven years. In 1995 he was transferred to serve the St. Croix Circuit as Superintendent Minister until 2002.

During his tenure in the St. Croix Circuit, he was elected in 2000 to serve as District President for the 2000-2003 triennium

In 2002 he was transferred to serve the St. Thomas/St. John Circuit as Superintendent Minister.

It is to his credit that during his first triennium as District President, a resident minister was stationed to advance the work of the Guadeloupe Mission; and the fledgling District Resources Centre became fully operational. He was re-elected District President for the following triennium.

As District President, Rev'd Vanterpool was also Superintendent Minister of the Curacao and Holland Circuits and the Guadeloupe Mission. He exercised keen oversight in these responsibilities.

He placed a high priority on ministry among young people, and his vision of Methodist Youth Ambassadors became real. His keen interest showed in many other areas such as ministry among men and women. Remembered as a counsellor, one who had a deep understanding of human nature, he was well known for bringing a personal touch even as he communicated with groups and organisations. He encouraged the spirit of Connexionalism throughout the District. His institution of the District Calendar helped to keep circuits and congregations across the District in touch with one another, through shared celebrations, successes, and concerns.

Rev'd Vanterpool superannuated in 2007 and continued to serve in the BVI Circuit as a supernumerary minister, until failing health and the passage of Hurricane Irma in 2017 precipitated the family's (Rev'd & Mrs Vanterpool's) move to Georgia, USA.

Throughout his service as a minister of the church, Rev'd Vanterpool was involved in the life of the wider community. He served the BVI on the National HIV/AIDS Committee, BVI Income Tax Appeal Board, The Territorial Advisory Committee of the University of the West Indies and the BVI Christian Council. He received several awards including his recognition as Member of the British Empire in 1990.

He was also a writer. His best-known publications are *The Inter-Relationship between the Role of Men in the Church and the Home* and *An Integrated Approach to Christian Stewardship based on the Methodist Class System.*

Rev'd Selwyn Vanterpool was married on August 17, 1972 to Brenda Louise and the young couple moved into his first ministry station- Montserrat. Their happy marital union bore three children- Beverly, Kenneth and Karen.

After a prolonged period of illness, Reverend Selwyn L. Vanterpool departed this life on 10th May 2021. He died in Georgia, USA during his eightieth year and in the fiftieth year of his ministry.

We give thanks for his commitment and faithful service in the Master's vineyard.

Tribute to Rev. Selwyn L. Vanterpool, M.B.E., M.A., M.P.S., M.A., L.Th.

The Rev. Selwyn L. Vanterpool, after a prolonged illness, passed away on 10 May, 2021 in Atlanta, Georgia USA, during his eightieth year and the fiftieth of his ministry.

Youngest of all his siblings, he was born at the Valley, Virgin Gorda, BVI on 24 January, 1942 to Jacob and Etma Vanterpool.

His early education began at St. Mary's Primary School in Virgin Gorda and later, at the Virgin Islands Secondary School on Tortola. This prepared him early in life, to give unstinting public service to his country and church, notably serving in the Civil Service as Chief Clerk of the Registrar's Office, and then as Clerk to the Attorney General. He also initiated the 4th Virgin Islands Boys' Brigade Company in the Road Town Methodist Church.

It is not surprising therefore, that Rev. Vanterpool portrayed that "creative tension" throughout his ministry, encouraging the church to work with the community in order to provide a frame of reference for communal action.

After serving in his home circuit, the Methodist Church BVI Circuit, as a Local Preacher among other roles, he answered the call to further serve his Lord and Master in the full-time ministry of Word and Sacrament. He was accepted and trained.

After graduating from the United Theological College of the West Indies (UTCWI), he worked extensively and with distinction in eleven Circuits and the one Mission in the Leeward Islands District, as Circuit Minister, Superintendent Minister and ultimately the District President.

Taking time off for studies in the UK and Canada, he was able to gain degrees in the Master of Arts programme and Master in Pastoral Studies, thus further preparing himself for a ministry of outreach and caring in the Caribbean at a most crucial time of social and political instability. He warmly embraced people throughout his ministry, and by the grace of God and by the power of the Holy Spirit, he performed meritorious work as Pastor, Preacher and Teacher with depth and sound doctrine.

A faithful, methodical, and efficient Circuit Minister and District President, he gave detailed care and attention to the administration of the church. Known as one whose word could be trusted, and in whom implicit confidence could be had as a beloved Pastor, he excelled. He had a way of showing real sympathy in ministry resulting in him being remembered by them long after he had moved on to other Circuits.

Although his quiet leadership, gentle spirit, reassuring smile, patient and conciliatory nature and gracious spirituality characterized his ministry, he could never be called a pushover. He was always able to act with necessary firmness as situations required.

Never short of ideas in an effort to move the church forward, and in spite of the challenges, he gave hope and guidance through the creation of the District Resources Centre. Circuits could now have a place to which they could refer for educational and other church related material.

Ministry among men and the youth were dear to his heart. This resulted in him preparing literature for Men's Work, and the organization of Youth Ambassadors throughout the District. Noteworthy was putting into the churches, hands and homes of members in the District, the creation of a yearly Calendar with pertinent information of Churches and Ministerial staff.

Rev. Vanterpool showed a brave and uncomplaining spirit and remained cheerful to the end. From time to time he would intimate that he was in a state of preparedness and "ready to go."

The entire Leeward Islands District mourns his passing and extends to his wife Brenda, and children Beverly, Kenneth and Karen our prayerful support and consolation.

Kind, warm-hearted, dedicated humble servant of God, your steadfast ministry of service will long be remembered.



When you assumed the office of District President in September 2000, few of us would have guessed that within three years the District Resources Centre would be operational and that a resident Methodist Minister would be in place to advance the work of the Guadeloupe Mission. You have given of yourself in service, conscious that much was expected of you. Knew that he who began a work in you is still with you and will see you through.

For your untiring efforts, Your passion to see the District advance, for your caring concern and all the invaluable service you rendered as District President, we give thanks and praise to God.

of your Ministry in Montserrat in 1972, to your Superannuation in 2007 and beyond, we conducted many worship

services together, visited the sick and shutins at home and in hospital, conducted seminars, and witnessed to others about the goodness of God. We supported each other wholeheartedly in whatever each of us was engaged in, whether it was improving the work of God or our own personal development.

Almighty God blessed us with three wonderful children. Beverly, a beautiful baby, was our first born in Antigua. We were both excited to have her and she brought much happiness to our lives. Four years later, immediately following your study leave in Canada, we were blessed with the gift of a handsome son Kenneth. Nine years later, God heard the prayers of Kenneth. MEMORY OF THE REVEREND SELWYN LORENZO VANTERPOOL

The Vanterpool family is one of the bedrock families when it comes to the fabric of the Virgin Gorda Community going back many, many years. The naming of one of the Administration buildings on Virgin Gorda after this family, shows the public's recognition and appreciation of this fact. Reverend Vanterpool will go down in history as one of the great stalwarts of the Virgin Gorda Community, though I will venture to say that many of our young people might not even know who he was. Most of my knowledge of his achievements came from reading a biography of him written by Mrs. Rosemary Delaney-Smith some eleven years ago.

As a child growing up in the Valley, we all knew of his mother, Ms. Etma as we called her, there is where we all went to get our candies and Christmas goodies. Reverend Vanterpool had a very shaky start in life, and it was doubtful that he would even live to become an adult. This just goes to show that when God is involved, purpose must be fulfilled. Reverend Vanterpool was the last child of Jacob Isaiah Vanterpool and Etma Clothilda Vanterpool, both Methodist lay preachers, so naturally he grew up in a Christian home with strong Christian values. At the age of three he became very ill and was not expected to live, but he did. Two years later, at the age of five he contracted typhoid fever and was once again engaged in a fight for his life, again he was not expected live, but again he did.

I heard many horror stories of the outbreak of typhoid in the BVI and the number of people that died from it, one account told to me by Mr. Rudolph Vanterpool is that at the height of the outbreak a nurse would walk the streets of Virgin Gorda with her syringe and vaccinate whoever she came in contact within an effort to save lives. Like all the other children in the Valley at that time, Reverend Vanterpool attended the St. Mary's Primary School. Unlike today, after primary school there was always the challenge of secondary education, for many persons their educational journey stopped right there. Reverend Vanterpool was the lucky student accepted from the St. Mary's Primary School that year and with the support of his family he made good use of the opportunity.

I did not know all his siblings but many years ago on a trip to New York, I met a lady at a function who introduced herself to me as my mother's childhood friend. I later found out that it was his sister Mrs. Ismay Elizabeth Vanterpool-Harrigan. She was a teacher in North Sound who left in 1952 to live and work in New York. Reverend Vanterpool had deep ties to North Sound as his maternal grandparents Charles Frett of the East and his wife Martha Fahie of Baughers Bay resided in North Sound, Virgin Gorda where Selwyns' grandfather was actively involved as a Methodist local preacher and was affectionately known throughout the community as Cousin Charlie. His paternal grandparents John Hamm Vanterpool of Tortola and Juliana White Vanterpool of the Valley brought a considerable amount of land at Taylor's Bay which is where they grew up as children, their home was called "Bethany Home". So, from these very humble beginnings, just like his siblings before him, he rose to great prominence in his chosen career. For many years the Reverend Selwyn Vanterpool had the distinct honour of being the only presbyter of the Methodist Church in the Caribbean and the Americas who is an indigenous native British Virgin Islanders. He would be later joined by the Reverend Nibbs Flores and the late Reverend Edris O'Neal. In his own words of his journey, he writes:

"There is no doubt in my own mind that, God instilled in me at a very early age the desire to go into the Pastoral Ministry. As a small boy, I felt that God was calling me to the Itinerant Ministry of the church. As I grew older, I tried to suppress this urge by telling myself, I could serve God in my homeland without going overseas. I intentionally became more and more involved in the life and work of the Church, and my community, in the hope of dismissing the idea of becoming an itinerant minister. Despite my efforts, I could not eradicate the matter from my mind.

In an effort to ease my

conscience, and put the issue to rest, I became a Lay Preacher. Soon after becoming a local/lay preacher, I heard the call of the Itinerant Pastoral Ministry stronger and clearer than ever before. In spite of all my efforts to silence the call, that inner, insistent, irresistible urge would not subside or go away.

On April 5, 1963, at an Evangelistic Service in Road Town Methodist Church, I completely surrendered my life to Christ. Like Isaiah, I acknowledged that I could not be effectively used by God to convert others, until I myself had the assurance of being converted. Soon after this spiritually transforming experience, my conversion, I realised that all along I had been resisting Gods' will for my life. Having become fully convinced that God had called me to the Christian Ministry, I embarked upon the vigorous candidating process. Having been thoroughly examined by the Church, which carefully checked to be assured of my call to the Christian Ministry, in January 1967, I was accepted as a candidate for the Ministry of the Methodist Church in the Caribbean and the Americas."

During his lifetime he received many awards in recognition of his service to the BVI and the wider Caribbean, but I believe that the one that he cherished greatly was when he was awarded the MBE for outstanding service in the BVI and regionally by Her Majesty Queen Elizabeth II in 1989, two hundred years after Methodism was introduced to the BVI in 1789. He was hoping to write a book on Methodism in the BVI, which I hope his dream can come to a reality as I know he would hold a very prominent place in it.

The life and service of Reverend Vanterpool should be an inspiration to all of us, a life of dedication, caring and giving of himself. On behalf of the Virgin Gorda Community, myself and my family, sincere condolences to his wife Brenda and children Beverly, Kenneth and Karen, his loving sister Calmelita Vanterpool-O'Neal and other relatives and friends. May his soul Rest in Peace and rise in Glory.

I did have the opportunity to catch up with him during a short time when we were both in Jamaica, he at the United Theological College of the West Indies and I at the University of the West Indies.

I have followed his progress through his Ministry both in North America and throughout the Caribbean always full of admiration for his accomplishments. I was equally impressed with his community service, particularly in improving relations between the public and the community in the nineties. His support for law and order combined with his love for his fellow men led him to give counseling services to those behind bars. Reverend Vanterpool as everyone called him was not only a Pastor but was indeed a stalwart of this territory. I was honoured to call him a friend. When he moved back to the BVI, in later years he and his lovely wife Brenda became our neighbours in Macnamara and we could not have asked for warmer and more generous neighbours. I know that his wife, their three children and his extended family are devasted by their loss but I hope that they will take comfort from the many memories they shared and the fact that this Community is a better place because of his many, many contributions. My heart goes out especially to Nurse Carmelita O'Neal his sister and a dedicated coworker of mine.

The Holland Circuit has fond memories of the Reverend Selwyn L. Vanterpool who served as Superintendent Minister of the Circuit during his first triennium as District President.

During the Connexional Year 2000 / 2001, he offered support to the Revered Douglas Field, a supernumerary minister from the British Conference who lived in Birmingham and visited to administer the Sacraments and otherwise give support to the work in Holland. In his dual capacity as District President and Superintendent Minister, Rev'd Vanterpool visited the Circuit in July and conducted meetings of the Circuit Councils.

On that visit he presided over the commissioning of Bro Alfred Glasgow as Circuit Pastoral Lay Worker, a development that boosted pastoral support for the general membership. Bro Alfred Glasgow recalls that Rev'd Vanterpool gave tremendous encouragement and support to these leaders who appreciated his help, which, in turn greatly boosted morale in the Circuit. He recalls that while miles distant, the Rev'd Vanterpool was near in heart, always available to counsel and guide.

The circuit warmly welcomed his presence on his next visit in April 2003. Some still recall his preaching at Rotterdam.

Sisters Theresita Adolphus and Glinder Rachards who served as circuit stewards remember his personal warmth and friendliness, and the good rapport Rev'd Vanterpool had with the members. They were happy that he visited again in 2004 for another Commissioning Service. Sis Adolphus also pays tribute for his untiring effort, using his influence working together with the British Conference to secure the services of a Methodist Minister from South Africa. He respected the circuit's desire not to be a circuit of the British Conference but rather to remain with the MCCA to which it felt stronger cultural ties. The Circuit appreciated him for that.

That year, they were thankful that he delivered on his promise and stationed a resident Superintendent Minister in the person of the Reverend Relis Martin-Riley, since the Circuit had operated for a while without a resident minister.

The Circuit offers condolences to Mrs Brenda Vanterpool, whom is remembered for her work among the women. It also conveys sincere regards to their children Beverly. Kenneth and Karen, and their families.

Rev. Vanterpool is one of very few ministers to have candidated from the US or British Virgin Islands. The attractiveness of lifestyle of this sub-region was not fascinating enough to deter him from candidating to what offered him a somewhat nomadic life. This decision of his to respond to the Call of God upon his life within that context, highlights the strong sense of Call that God had upon his life, his deep commitment to God, Church and ministry and his passion for the mission of the Church.

It is not surprising that these qualities were recognized by his colleagues and the leadership of the Leeward Island District who elected him to serve in the highest office in the District. As President, at a critical juncture in the evolution of the Leeward Island District, the Guadeloupe Mission was realized, the resurgence of youth work materialized, as well as the general streamlining of the District and Circuit activities.

Rev. Vanterpool was among a select group of Leeward Island Ministers who tapped into a spirituality that is unique to this District. It is a spirituality that does not sit comfortably with the status quo, but is characterized by visionary and transformational leadership, hard work and commitment to the work. As such, it gives priority to kingdom building. These Ministers demanded much of themselves and equally so of others in the Church, not just to engage in ministry but to engage in ministry par excellence. Essentially, they were uncomfortable with mediocrity. Such a spirituality arises from a clear sense of Call, a firm and personal experience of Christ in God, a commitment to study and continuous development and thoroughness in preparation at all times. It is a case of 'give of your best to the Master'.

The St. Croix Circuit desires to place on record its gratitude for the seven years of service rendered by Rev. Vanterpool as Superintendent Minister and Pastor from 1995-2002. Rev. Vanterpool's formative years were characterized by tenacity, commitment to the work, visionary leadership, pastoral compassion and invaluable service. Many still remember vividly the stewardship programme undertaken during his tenure and its impact on all areas of the life of the Church, and to its witness, at that time and thereafter. It was during his ministry on the island that the Circuit hosted its first and only District Conference to date.

His death reflects the passing of one of a cadre of Methodist Ministers who gave more than they received. As Luke 12:48 states, "*To whom much is given, much will be required*". We thank God for his life, witness, ministry and service. May he rest in peace and may God comfort and protect his surviving relatives and loved ones.



Tribute to the Rev. Selwyn Vanterpool on behalf of the Antigua Circuit

The Antigua Circuit of the Methodist Church in the Leeward Islands District Conference is honored to pay tribute to the life and ministry of the Rev. Selwyn Vanterpool. In 1967, he was appointed to serve as a Pre-collegiate Minister for one year in the Antigua Circuit.

In 1975-1977 Rev. Vanterpool was stationed in the Antigua Circuit where he had pastoral oversight for the Barrett Memorial, Baxter Memorial, Freemansville and Sawcolts congregations. During his ministry here many memories were created as he celebrated events in the lives of his members which were either of a joyous or sorrowful nature. His journey with his members in these events reflects the memoirs of a pastor's impact on his congregations.

During his tenure at the Sawcolts Methodist Church, the Rev. Vanterpool endeavored to optimize the spiritual, emotional, social and physical wellbeing of his members. His love and concern for his members could never be denied as there were too many reminders. For instance, he was never too busy to give a listening ear to his members; he knew where they all lived, and he also shuttled them to and from Leader's Meetings.

Rev. Vanterpool was a source of encouragement and support when the congregation attempted to raise funds to purchase their first Church organ. He also provided his members with special training seminars to bolster their faith and conviction, when at times other denominations were pushing spiritual and religious matters and practices aimed at eroding the confidence and practices of the Methodist Church.

For those who were skeptical about God's grace and his ability to work miracles, Rev. Vanterpool testified to the night when death came knocking at his door. After taking some leaders home from Leaders Meeting he proceeded home and to his dismay the brakes of his Austin BMC failed (cut away) as he was going down Follies Hill, but by the grace of God he survived the ordeal.

Rev. Vanterpool was beloved by members of his congregations, especially Sawcolts, and others whom he came to know and who came into contact with him. He was tagged as the "People's Pastor". At the end of his tenure, a Farewell Service was held at Sawcolts and the hymn "God be with you till we meet again" was sung and many persons wept, knowing that chances were they may never see him again.

Charles Wesley's hymn .. MHB 484 .. "Soldiers of Christ arise and put your armor on" and specifically verses 3 & 4, testify to the type of person Rev. Vanterpool was as he defended the faith of the Methodist Church at that time.

"Stand then against your foes,
In close and form array,
Legions and wily fiends oppose
Throughout the evil day.
But meet the sons of night,
But mock their vain design,
Armed in the arms of heavenly light,
Of righteousness divine.

Leave no unguarded place,
No weakness of the soul,
Take every virtue, every grace,
And fortify the whole.
Indissolubly joined,
To battle all proceed;
But arm yourselves with all the mind
That was in Christ your Head."

To God be the glory for a life lived in service to his God and his generation. May the God of heaven receive him in his everlasting arms. We extend our deepest sympathy to his family and friends and pray that God will grant you strength and grace to sustain you during this time of bereavement. May his soul Rest In Peace!

In Memory of Rev. Selwyn L. Vanterpool, MA, MFS, LTh, MBE



Rev. Selwyn L. Vanterpool, MBE, a true and humble man of God, was a beloved son of the Virgin Gorda soil. He spoke the Word of the Lord quietly and clearly; and listened patiently to others, remembering that each has his or her story. He, too, had his own story, of which we count it a privilege to have heard him repeat whenever he got the opportunity, as he was mostly stationed in other Circuits. Rev. Vanterpool would fondly say of Valley Methodist Chapel, "This is where I was hatched, this is where I was matched, and God willing, from here I will be dispatched." On the occasion of the 210th Anniversary of Methodism to Spanish Town in October 2004, Rev. Vanterpool penned:

"The Valley Methodist Chapel holds a special

place in my heart. It was here that I was baptized and attended Sunday School, Morning & Evening Services, as well as "Wesley Guild" as a youngster. It was to this beloved chapel that I returned to be comforted during the funeral services of my brother James, and my parents Jacob and Etma Vanterpool, both of whom served as Methodist lay preachers. Approximately 30 years following baptism, I was married to my wife Brenda Louise at the Valley Methodist Chapel. God willing, I look forward to completing my cycle at the place where it all began."

(Valley Methodist Church 210th Anniversary Booklet, Oct 2004)

At that time, Re-Dedication of the Chapel, Valley Methodist Congregation honoured Rev. Vanterpool with the Release of a Limited-Edition Commemorative Coin, in consultation with the Connexional and District Presidents of the Methodist Church in the Caribbean and the Americas (MCCA). Rev. Vanterpool was at that time the Leeward Islands District President. On the obverse of the coin was a rendering of the Chapel and inscription "The Love of Christ Constrains Us" with the years 1794-2004 and Methodism in Virgin Gorda, BVI. On the reverse of the coin was a portrait of Rev. Selwyn Lorenzo Vanterpool and the inscription "First Native Virgin Gordian Ordained 1974". 100% of the proceeds from the sale of these coins went towards offsetting the cost of repairing and refurbishing Valley Methodist Chapel.

Rev. Vanterpool lived his philosophy, which included "A quiet inner confidence and faith that God is with him to equip and enable him to meet whatever the challenges are." He valiantly championed the cause of our Lord and Saviour Jesus Christ until the end with his quiet demeanour, knowing deep within as the hymnwriter penned, "There'll be peace in the valley for me some day, There'll be peace in the valley for me." (Thomas A. Dorsey, Voices In Praise #354 chorus)

Sincere sympathy to Sis. Brenda (widow) and their Children, Sis. Calmelita (sister), Sis. Dawn (niece) and the rest of the Family, as they continue to hold on to the hand of the Master. The peace of our Lord be with you always and may his soul rest in eternal peace.

Today we mourned the passing of our dear beloved friend Rev. Selwyn Vanterpool. Rev. Vanterpool has given much of his life serving God and his fellowmen. He led a remarkable life while working tirelessly in the building of his church and community. His pleasant personality, along with his gregarious nature and God-fearing attitude, provided a safe place for persons to interact readily with him.

The songwriter reminds us "that If I carry the gospel to the lost near and far, I won't stand empty handed at God's Judgement Bar. But I dare not relax until I have done all he asks." Very rarely does one find such an influential and accomplished couple to be so charitable and humble in their action towards others. These words best described Rev. Selwyn Vanterpool and his Local Preacher wife, Brenda. My husband Vernon was appointed Police Commissioner of the Royal Virgin Islands Police Force in 1992. At a time when the British Virgin Islands saw some turbulent times with the increase in crime. Vernon had recently graduated from Law School with his long career in policing and held a passion for the love of his country. The Government of the day promoted him to lead the force hoping that he would bring the country back to its normal state of tranquility.

To assist the Commissioner of Police and his men, the then Governor Peter Penfold, in his wisdom, created an Advisory Committee in 1992 and made Rev. Selwyn Vanterpool Chairman. From the onset of his appointment, Rev. Vanterpool forged a strong and supportive relationship with the Commissioner of Police (my husband). In turn, the entire Malone family benefited from that close relationship. In his quiet professional demeanor, Rev. Vanterpool provided unwavering and robust support to my husband. This relationship and other mitigating factors undoubtedly help to bring success to the Royal Virgin Islands Police Force. His legacy of kindness, compassion, and professionalism will remain in the minds and hearts of his family, his flocks at the church, and all the many lives that he has touched. I am often mindful of the words of the great Catherine McAuley (Founder of the Sisters of Mercy) when she wrote, "If the Love of God really reigns in your heart, it will quickly show itself in the exterior. Day after day, Rev. Vanterpool portrayed those characteristics.




